**Renewal of Licence for Operation of the Gamma Radiation Processing Facility
(Category-IV), of M/s Gamma Agro-Medical Processing Pvt. Ltd., Hyderabad**

1. In exercise of powers conferred under Section 16 of the Atomic Energy Act, 1962 read in conjunction with Rule 3 of Atomic Energy (Radiation Protection) Rules, 2004 {AE(RP)R-2004}, the Atomic Energy Regulatory Board (AERB) hereby renews the **Licence** issued vide AERB/RSD/Licence/R1/RPP-14/2014/10105 dated October 31, 2014 in favour of the **Managing Director, M/s Gamma Agro-Medical Processing Pvt. Ltd. (GAMPPL), Hyderabad** for operation of their Gamma Radiation Processing Facility (GRAPF), Category-IV, located at Plot No. 1, Road No. 4, Export Promotion Ind. Park, IDA, Pashamylaram, Dist. Medak, Telangana.
2. The strength of ^{60}Co source in the gamma radiation processing facility of M/s GAMPPL, Medak shall not exceed **37 PBq (1000 kCi)**.
3. The gamma radiation processing facility shall be operated, used and maintained in accordance with provisions of AERB Safety Code on Radiation Processing facilities; AERB/RF-RPF/SC-1 (Rev.1), and other applicable documents issued by AERB.
4. The Managing Director, M/s GAMPPL, Medak shall be responsible for the safety of the personnel of radiation facility, physical security of the radioactive sources, servicing, maintenance, decommissioning and dismantling of radiation facility and safe disposal of radiation sources by returning such sources to the original supplier or at authorized radioactive waste management facility with prior approval of AERB.
5. The Managing Director, M/s GAMPPL, Medak shall keep AERB informed about the radiation safety status of their gamma radiation processing facility. Such information shall be in the form of reports to AERB in the month of April, July, October and January every year.
6. Any radiation safety related unusual occurrence shall be promptly reported to AERB.
7. This Licence renewal is valid till **November 20, 2020**.
